## Washington State Department of Early Learning

### New Payment Option for Background Check Applications

Beginning February 22, the Department of Early Learning (DEL) will accept credit and debit card payment for background check applications.

#### Acceptable payment options for background applications include:

- Automated Clearing House (ACH) is an electronic withdrawal directly from your checking or savings account.
- Debit or credit card (beginning February 22)
- Check, money order, or cashier's check

#### Does DEL allow purchase orders?

Not at this time. The approved ways to pay for the background check application fee are by check, money order, cashier's check, ACH, debit card, or credit card.

### Próximamente: nueva opción de pago para las solicitudes de verificación de antecedentes

A partir del 22 de febrero, el Department of Early Learning (DEL, Departamento de Aprendizaje Temprano) aceptará pagos con tarjeta de crédito y de débito para las solicitudes de verificación de antecedentes.

#### Las opciones de pago aceptables para las solicitudes de antecedentes incluyen las siguientes:

- La Automated Clearing House (ACH, Cámara de Compensación Automatizada) consiste en un retiro electrónico que se realiza directamente de su cuenta corriente o de ahorros.
- Tarjeta de débito o de crédito (a partir del 22 de febrero)
- Cheque, giro bancario o cheque de caja

## ¿El DEL permite órdenes de compra?

Por el momento, no. Las formas permitidas de pago de la tarifa de solicitud de verificación de antecedentes son cheque, giro bancario, cheque de caja, ACH, tarjeta de débito o tarjeta de crédito.
