ECEAP is Washington's state-funded prekindergarten program that prepares some of the state's most vulnerable 3- and 4-year-old children for success in school and in life. The Washington State Department of Early Learning (DEL) oversees the program. Since 1985, ECEAP has focused on the well-being of the whole child by providing comprehensive nutrition, health, education and family support services to Washington's most at-risk children. ECEAP becomes a statutory entitlement in school year 2020-21, per House Bill 2731, which passed in the 2010 legislative session. This means that by Fall 2020, all eligible children in our state whose families choose to participate, will be able to attend ECEAP. In order to meet the demand for eligible children, Washington is significantly expanding ECEAP.

Because the number of requested slots from applicants did not reach our expansion goals for this year, we are having another round of requests for applications.
